1. The petitioner has filed the complaint before this court on 21-01-2017 with the following relief:-

2. On 12-12-2017, the complainant appeared before the court and has got recorded his statement that his grievance has been redressed. He is not interested to proceed further with the instant claim, resultantly the claim was dismissed as being withdrawn on 12-12-2017.

3. The factual matrix for filing the instant petition are that during the pendency of the claim, on 30-05-2017 the following order was passed and the pant Coat was produced in the court as Ex-P1 for seeking expert opinion:-

" Muhammad Rizwan has submitted the written reply of the application and learned counsel seeks time for submission of written reply on behalf of the other defendant. The claimant along-with his counsel has appeared and produced the alleged three piece pent-coat. It has been alleged by the claimant that defective product has been supplied by the defendants to him and this controversy regarding defective product can be resolved by inviting the expert opinion as per law. In this regard the Principal Govt. Vocational Training Institute (W) Jalapur Jatta Road, Gujrat is directed to appoint an expert. Therefore, the three piece pent-coat Ex. P1 be send to Principal Govt. Vocational Training Institute (W) Jalapur Jatta Road, Gujrat with the direction to submit his / her detailed report that whether the present product supplied to the claimant is defective as alleged by the claimant for the proper guidance of the Court. The copy of this order along-with the copy of claim be send to the Principal Govt. Vocational Training Institute (W) Jalapur Jatta Road, Gujrat for strict compliance. The fee of the expert is fixed Rs. 2000/-, which shall be paid by the claimant with the Registrar of this Court who shall send the pent-coat Ex.P1 to the Principal mentioned above. The expert is directed to submit his/her opinion/report on the next date of hearing. The expert shall also appear on the said date as CW for recording his/her evidence. Now to come up on 12-06-2017".

4. As controversy between the parties has been redressed after settlement therefore, the instant application is accepted and Pent Coat Ex-P1 deposited in the court be handed over to the claimant/petitioner. File be consigned to record room after due completion.
